# RUSSIAN AVIATION UPDATE State Authorities Regulating the Aviation Sector

December 15, 2004

To Our Clients and Friends:

Recent changes to the structure of executive bodies in Russia were implemented as part of an administrative reform package to cut administrative costs, provide a more streamlined, efficient working environment and present more user-friendly government services. While on paper these changes appear to represent a more manageable distribution of powers and a step towards better government, it is too early yet to say what real effect this will have for business. This update singles out the most important changes affecting the aviation sector.

## I. GENERAL OVERVIEW

On March 9, 2004, the President issued Decree No. 314 On the System and Structure of Federal Executive Bodies (the "Decree") significantly changing the structure of federal executive bodies in Russia. The Decree establishes three types of federal executive bodies – ministry, service and agency. The Decree defines and segregates the functions of these bodies. In general, ministries are put in charge of legal regulation of a specific sphere, while control, monitoring and supervision is delegated to federal services. Federal agencies are responsible for management of state property and enforcement. Federal services and agencies in most cases report to their respective ministries, which may revoke their decisions if inconsistent with legislation. Federal services and agencies are also entitled to issue individual legal acts within their respective competence.

#### II. CHANGES TO REGULATORY BODIES IN THE AVIATION SECTOR

#### A. Air Transport

State regulation of air transport is within the competence of three new bodies:

- **1.** Ministry of Transport;
- 2. Federal Service for Transport Supervision; and
- **3.** Federal Air Transport Agency.

The *Ministry of Transport* forms state policy and drafts legislation and normative acts in the sphere of air transport. It is also empowered to adopt a limited number of normative acts, such as rules of state registration of civil aircraft. The ministry is responsible for the following matters: structural reform in the transport sphere; development of air transport (civil aviation); international cooperation; budget financing; expert appraisals; forecasting; and security issues in the transport sector. The ministry's head is Igor Y. Levitin. A brief biography of Mr. Levitin is in Annex A to this update.

The *Federal Service for Transport Supervision* ("FSNT") reports to the Ministry of Transport. It is responsible for control and supervision in the sphere of air transport. Its primary control and supervision functions with respect to air transport include compliance with legislation, licensing, certification, registration and accident investigation.

The FSNT licenses almost all types of activity in the aviation sector, including technical service and maintenance of aircraft. It is also responsible for certification issues, including certification of operators and organizations for technical service and maintenance of aircraft. The FSNT issues licenses, certificates and other permits in its respective competence. Among the main powers of the FSNT are state registration of civil aircraft and organization and conduct of flight suitability checks of civil aircraft. The head of FSNT is Alexander V. Neradko. His biography is attached as Annex B.

It should be noted that type certification of aircraft is within the competence of the *Interstate Aviation Committee* ("IAC"). The IAC was formed on the basis of the intergovernmental Agreement on Civil Aviation and Air Space Use, signed on December 30, 1991. The IAC is an executive body of 12 former USSR republics (all but the Baltics) for certain functions in civil aviation. The IAC is a supranational body and is not formally subordinated to any Russian authority. The chair of IAC is Tatyana G. Anodina, Annex C contains her short biography.

The *Federal Air Transport Agency* (also known by its Russian acronym FAVT) reports to the Ministry of Transport. Its primary functions include implementation of federal programs, operation modernization of the civil Integrated Air Traffic System, organizing international and internal flights, and keeping registers and cadastres. The head of FAVT is Nikolai V. Shipil; his biography is attached as Annex D.

The other state executive body that regulates activity in the aviation sector is the Ministry of Industry and Energy. Among its general functions is the creation of state policy and drafting of legislation and normative acts with regard to the development of aircraft technology. Annex E contains a short biography of the head of this ministry, Victor B. Khristenko. The aviation issues at the ministry are covered by the Division of Aviation and Maritime Activities at the Department of Defense and Industrial Complex. The head of this division is Vladimir I. Babkin (his biography is attached as Annex F).

# **B. Taxes and Customs**

The other key governmental functions affecting aviation are taxes and customs.


On the ministerial level, the Ministry of Finance forms state policy and drafts legislation on taxation, currency transactions and customs payments. Alexey L. Kudrin heads the Ministry of Finance; Annex G contains his short biography. Within the Ministry of Finance, Department for Tax and Custom Policy is headed by Mikhail A. Motorin. His biography is attached as Annex H.

The main supervisory body in the area of taxes and levies is the Federal Tax Service, which reports to the Ministry of Finance. The competence of the Federal Tax Service includes control and supervision of tax compliance, as well as of compliance with certain aspects of Russian currency legislation. The head of the service is Anatoly E. Serdyukov. His biography is attached as Annex I.

General customs control issues are within competence of the Ministry of Economic Development and Trade, which is headed by German O. Gref (his biography is briefly described in Annex J). The ministry forms state policy and drafts legislation on foreign economic activity, customs issues and trade. The Ministry of Economic Development and Trade is entitled to adopt certain normative acts in its respective area defining, *inter alia:* procedures for control of the customs value of goods and carriers (together with the Ministry of Finance); lists of documents and information to be lodged for customs clearance under various specified customs procedures and customs regimes; as well as deadlines for the submission of such documents and information.

The Federal Customs Service is responsible for customs control and supervision. The service collects customs duties, taxes and customs levies, oversees the accuracy of its calculation and timeliness of its payment, and performs customs clearance and customs control. The Federal Customs Service reports to the Ministry of Economic Development and Trade and is headed by Alexander Y. Zherikhov (his biography is attached as Annex K).

The following chart describes the organizational structure of executive bodies mentioned in this update.

### Alexander Vasilievich NERADKO Head of the FSNT

## Born 1961.

Graduated in 1984 from the Moscow Institute of Civil Aviation Engineering (now the Moscow State Technical University of Civil Aviation). Various engineering and management positions in the field of civil aviation followed, as well as in the State Commission for Supervision of Aircraft Flight Safety, Intergovernmental Aviation Committee, and in federal aviation agencies.

From 1997 Head of the State Supervisory Board for Flight Safety of the Russian Federal Aviation Service (Federal Service for Air Transport). Member of industry collegium. Specialized in aircraft flight and technical operations systems and flight safety. Directed the development of an integrated system for flight safety control. In implementing a policy of more rigorous standards and accountability, has contributed greatly to improvement in recent flight safety statistics in scheduled civil aviation operations. Maintains business contacts with manufacturers of aviation equipment, design engineering bureaus, Rosaviakosmos, the air force, ICAO. As a highly-qualified expert and manager was active in helping prepare and adopt a number of government resolutions and statutes as well as industry papers on improvements in civil aviation flight safety in Russia.

August 2000 to March 2004 – First Deputy Minister for Transport, RF, Head of the State Civil Aviation Service, Chairman of the State Civil Aviation Service of the Ministry of Transport of Russia.

Born in Leningrad, the daughter of a military pilot.

Received the Edward Warner Award in **1977** – the highest honor of the International Civil Aviation Organization.

Doctor of Engineering, Professor and Academician.

**1991** appointed Chairperson of the Interstate Aviation Committee, the body that controls all C.I.S. airspace.

# Nikolai Vladimirovich SHIPIL

Head of Federal Air Transport Agency

## Born 1955.

Graduated in 1975 from the Leningrad Technical College of Civil Aviation and in 1980 from the Leningrad Finance and Economics Institute. Completed advanced education training for management at the Civil Aviation Academy in 1984, was a graduate student there, and in 1991 graduated from the Russian Government's Academy of the National Economy. From 1985 to 1989 was Aeroflot's general representative in Switzerland.

From December 1989 to April 2000 held various management positions at Pulkovo Airlines, including Deputy Head of International Routes and Deputy Head of Airline Performance. From April 2000 to March 2004 was head of the state transport company Rossiya.

Awarded the Expert Air Transport medal and the title Honored Transport Worker of the Russian Federation.

By Order of the Government of Russia No. 376 R dated March 18, 2004 Nikolai Shipil was appointed Head of the Federal Air Transport Agency.
