



Advising a consortium of international EPC contractors on contract management issues for the **construction of several major structures in an international airport**, including preparation of records and correspondence; assisting in preparation of contractor claims; responding to employer claims; advising on negotiation strategy; and representing clients in meetings and contract dispute resolution processes.



Advising a Peruvian power company on its rights and remedies against a contractor and subcontractor following the failure of generators installed in a new dual-fuel power plant. Following contractual correspondence and a series of negotiations, the issues were settled and the power plant was quickly returned to operation.



Advising and representing the owner of a ship yard on contracts worth \$4.6 billion for the construction of several ship-shape drilling platforms for use in deep water oil and gas exploration, including advising from an early stage on strategies for protecting contract rights, continued performance of the works and potential avenues for renegotiation. After a change in the circumstances, we advised on strategies for exiting from the contracts, establishing claims against the counterparty in excess of \$1 billion and preparing for potential formal arbitration proceedings, eventually leading to a successful settlement.



Advising and representing Transport for London as owner on the contracts for the extension and upgrade of the East London Line and North London Line. Assisting in negotiations for the contracts when they were first executed, and continued through two years of advising on contract management including five adjudication, two mediations and one English High Court litigation. Ultimately all of the claims were settled and the project was completed successfully.


